You will need to produce 2 documents, which include your full name, your home address and your date of birth. We need to see one of the following original documents to confirm your identity;

■ **Valid Passport** ■ **Valid photo card Driving Licence (full or provisional)** ■ **ARC (Asylum Registration Card)**
■ **Home Office status letter** ■ **Benefits Agency/ DWP/ Employment Service documents** ■ **Certificate of British Nationality**

We need to see one of the following to confirm your address which is no more than 3 months old;

■ **Inland Revenue documents** ■ **Current Utility bill** ■ **Bank, Building Society, Mortgage, Credit Union or Credit Card Statement**
■ **Council Tax bill or other Local Authority documents** ■ **Tenancy Agreement** ■ **Court correspondence**
